Research Results for ZAPS ACT Test Preparation Delivered by Trained Teachers in Boulder Valley School District, Colorado

In January of 2010, three schools in the Boulder Valley School District, Colorado, contracted with *ZAPS* Learning Company to train a group of faculty members to present the *ZAPS* ACT test-preparation curriculum within the district. The trained faculty members at the three schools — Arapahoe Ridge (district alternative high school), Broomfield, and Centaurus — went on to instruct the entirety of each schools' junior class in the *ZAPS* ACT test-preparation strategies program.

In October 2010, the Boulder Valley School District published the results of ACT test scores within the district over the past seven years. The data was unique in that it allowed for a comparison with the ACT score pre- and post- ZAPS participation (3 high schools, 616 students), as well as the scores of the Control Group who did not offer the ZAPS training to the teachers or students (7 high schools, 1535 students).

The ACT Composite score at the three participating high schools was up an average of 1.4 points. In comparison, students in the Control Group showed a very slight decline of -0.1 points during this same time period.

Performance on subject-area subtests was fairly consistent with the Composite gain in each of the three participating high schools. On average, students improved 1.5 in English, 1.4 in Math, 1.5 in Reading, and 1.2 in Science (See Table 4).

The data published by the Boulder Valley School District indicates that *ZAPS* ACT training had a significantly positive impact on the ACT scores of students who participated in the trial.

Follow Up Note—

Performance in 2011 continued to improve at the three high schools offering the *ZAPS* program. On average, the ACT Composite Score improved from 16.9 in 2009 to 18.3 in 2010, and to 19.4 in 2011.
